Chairperson's Message

The strength of a community is people helping people. Oxford County over time, has always responded to the challenge of meeting specific needs when they were required. In late 2001, a group of County residents began to discuss the possible formation of a Foundation that could serve the needs of the entire community.

A steering committee was formed in 2002 and through their dedication the Oxford Community Foundation was incorporated. Slowly and through the diligent efforts of more volunteers, the Foundation received its official Charitable Status in 2003. A vision and a mission statement were established that formed the basis to encourage the flow of available resources that could effectively meet the requirements of the entire community. We are now a full-fledged and well-managed organization that is the catalyst to attract resources, manage permanent endowment funds and respond to the emerging needs of our County.

The Foundation received its first permanent endowment from the Alabastine-Wilkinson family. A "Fund Held for Others" in the name of the Children's Aid Society of Oxford County was established. Grants were also received from the County of Oxford and the Ontario Trillium Foundation to help support operations to get the foundation up and running. We made our first set of grants to five organizations and partnered with several others organizations to provide a Grant Writing Workshop and to explore environmental priorities within the County.

Highlights of the year include: the production of our brochure, completion of our first strategic plan, launch of the website and hiring of a part-time executive director.

The Foundation is indebted to the many volunteer hours of planning which have been so freely given by the board members and other community volunteers. Several 'in kind' donations of services have also been received.

There is great satisfaction in seeing a dream come together and know that this dream will continue to enrich Oxford County forever. Our successors will ensure that the legacy, which has begun, will continue to grow.

Partnership

Benjamin Moore Community Restoration Program

The Community Foundation of Canada has partnered with Benjamin Moore to administer their Community Restoration Program. As the local community foundation, we were pleased to promote and assist with the presentation of \$5,500 in grants and paint product to the Woodstock Public Library and the Beachville District Museum.

County of Oxford

The County of Oxford has indicated a sincere and tangible commitment to ensure the Oxford Community Foundation becomes established to serve the people of Oxford County. A three year commitment of "seed money" to support the formation of the Foundation has provided the stability to move forward.

Ontario Trillium Foundation

The Oxford Community Foundation was successful in gaining support from the Ontario Trillium Foundation to assist with operational start up of the Foundation. This support will allow the foundation to reach all communities within the County and to provide leadership to the broad spectrum of registered charities.

Kick-Start Program

Oxford was one of twelve community foundations in Canada to receive from Community Foundations of Canada, a J.W. McConnell Family Foundation grant of \$15,000 to assist in launching an environmental program and establishing an environmental endowment.



Leadership

Oxford Community Forum 2006

The Foundation partnered with the Ontario Trillium Foundation, Oxford Small Business Support Centre Inc., Industry Canada, OMAFRA and United Way of Oxford to conduct "An Oxford County Community Forum 2006", to assist charities in Oxford County in providing an educational opportunity to learn where to access funds and how to write effective funding proposals.



Public environmental forums were held in Woodstock and Tillsonburg to hear concerns, recognize priorities and identify criteria which will be considered in the development of an environmental granting stream.

Cultural Community

Initial discussions have occurred with the Oxford Cultural Task Force regarding the potential of establishing a cultural council and a 'Field of Interest' granting stream.

The above statement of revenues, expenses and changes in fund balances has been excerped from, and should be read in conjunction with, the audited financial statements of Oxford Community Foundation for the year ended December 31, 2005.

Treasurer's Report

After relying on Len Reeves and his company for financial support through 2003, 2004 and 2005, the Foundation gained financial stability in 2005 when it received a three year commitment of \$25,000 per year in the form "seed money" from the County of Oxford.

In addition, we are receiving a Grant form the Ontario Trillium Foundation over 2005, 2006, 2007. This enables the Foundation to hire an Executive Director to help us reach the necessary fund development goals in order to be self-sufficient. Our initial projections to be self-sustaining mean we can leave no stone unturned in developing our Endowment Funds. We are looking forward to 2006 and 2007 with anticipation with Pat at the helm.

We have the internal systems in place now to support our efforts.

As chair of the Investment Committee, I am pleased to report that a 20.8% return on investment was achieved on the \$25,000 Alabastine-Wilkinson which was received in April 2005.

RBC Dominion Securities, our investment manager, are not charging any fees at the present time. The Foundation charges 1.5% as its administrative fee. In addition, a capital preservation percentage is added to the capital each year from earnings to preserve the purchasing power of the investment. It essentially coincides with the increase in the cost-of-living index. For income tax purposes we are required to grant out 3.5% of the capital.

The Oxford Community Foundation and its Investment Committee are very prudent with the investment manager when it comes to investing. Extremely sound policies have been established which the Committee monitors.
