
# Message from Board President and Executive Director

Since its inception, Oxford Community Foundation (OCF) has been a catalyst to attract community resources and to direct funds in perpetuity within Oxford County.

The Board of Directors and committee volunteers continue to forge Earl Shea - President new partnerships to promote philanthropy. This year there was an emphasis on creating awareness of causes and opportunities through presentations to political, community, and service organizations.

Community development actively remained the focus of the Foundation. It involved partnerships with the cultural community, the Oxford Youth Strategy Committee, along with champions of the environment and agencies which support volunteers.

Through the generous support of our donors, three new funds were established in 2006 and the Founders Circle program was launched. The Foundation has been able to attract new donations and through strong investment returns a solid financial base is being created.

OCF is a member of Community Foundations of Canada, a national network of local foundations where grants are directed to assist urban and rural organizations. This year OCF awarded nine grants throughout the county. Making a lasting difference is what really matters and the Foundation has been working to build local knowledge that helps connect donors to the causes and organizations that matter most to them.

The Foundation is truly indebted to our Board and other community volunteers for their tireless efforts in making the Foundation a worthy and contributing organization.

To enhance the quality of life throughout Oxford County by fostering community philanthropy.

# What is Oxford Community Foundation (OCF)?

Oxford Community Foundation is one of 155 community foundations across Canada established to be:

- the steward of funds, which are pooled in a permanent endowment to serve the Oxford community in perpetuity;
- the administrator of grants to a wide range of interests through registered charities committed to making a difference in the quality of life in the county;
- a leader in identifying needs and working with other community agencies to assist organizations and communities of interest. The Foundation acts as a catalyst for innovative approaches to connect people and causes to make a difference in Oxford.

# Types of Funds within OCF

- Community Fund This unrestricted endowment fund allows the Foundation to identify and respond
  to ever-changing needs by focusing dollars on creative and effective grants. These may be awarded to
  an extensive range of needs such as: arts and culture; health; education; recreation; environment
  and social services.
- Field of Interest Fund The donor decides which area of need the fund should help. Grants will be given which will impact that field of interest.
- Donor Designated Fund Donors can ensure that grants will be awarded to their chosen organization(s).
- Agency Endowment Fund Charitable agencies may establish permanent endowment funds, the income
  of which will provide operating support forever.
- Donor Advised Funds The donor recommends specific grants from the fund, based on his/her interests.

# Service to Donors

The Foundation works with donors to make it easy to give back to the community by creating a named fund or contributing to an existing fund. Donors who endow their gifts can make a difference in the community during their lifetime, and at the same time, provide a gift that lasts forever.



# Why choose OCF?

#### Investment

Stewardship is one of Oxford Community Foundation's most important responsibilities, requiring strict oversight and intelligent investment. Management of the Community Foundation's portfolio is vested with the Board of Directors through the Investment Committee.

With an investment policy developed jointly by the Investment Committee and our investment consultant at RBC Dominion Securities, the Community Foundation delivers excellent returns. OCF is fortunate to have the experience of these individuals to establish performance benchmarks and continuously monitor portfolio effectiveness. The Investment Committee adheres to a disciplined process, regardless of market fluctuations, to ensure the integrity of the Foundation and the preservation of donor intent in perpetuity.

#### Our Funds

# Community Fund

As OCF continues to grow, the unrestricted Community Fund provides the underlying heart of the Foundation. Donations of all sizes are combined to provide the means to operate the Foundation and provide the Grants Committee with the most flexibility in meeting community needs. In December 2006 we began the Founders Circle to accelerate the growth in the Community Fund.

# Douglas and Yvonne Eckel Fund

Yvonne and Doug have been significant contributors to many worthwhile causes over the years. It is part of their "give back" make up. They believe that the Foundation is the best way to benefit others for generations to come. The variety of activities supported make any donation to a community foundation appealing.

As treasurer, Doug knows better than anyone else the importance of building a stable base to support the Foundation. He and Yvonne chose to create a named fund within the unrestricted Community Fund. In May 2006 the federal tax laws changed allowing individuals to donate stocks and securities to community foundations without having to pay tax on the capital gains on their appreciated value. Doug and Yvonne chose to donate securities receiving a tax receipt for the current value of their stock and without having to pay tax on the capital gain. This allowed for a greater donation to the Foundation. This was truly a 'win, win' situation.





# Field of Interest

# Brian and Rosemary George Cultural Fund

Brian and Rosemary have both been very active in the community providing and supporting musical and theatrical productions, the Rotary Music Festival and providing leadership on various volunteer boards and in their church. It is not surprising they were two of the first donors to step forward in order to give back. Their lives have been enriched by cultural opportunities. They chose to create the Brian and Rosemary George Cultural Fund so that others might also be able to participate in cultural experiences. Their action has served as an inspiration to Helen Darby who annually contributes to the George Fund as an expression of gratitude for the lessons and transportation her late mom provided to enrich her life. It has become Helen's unique way of honouring her mom's birthday. Currently this is an Emerging Fund. Grants will begin to



be made from this fund when the capital commitment to establish the fund is complete.

# Oxford Environmental Legacy Fund

This fund currently is valued at over \$10,000. The fund was made possible through the generous support of the J.W. McConnell Family Foundation and the County of Oxford as matching contributors. Grants from this fund will be used to educate and promote sustainable environmental projects and practices throughout the County.

# Fund Held for Others

Oxford Community Foundation assists the Children's Aid Society of Oxford County by investing an independent agency fund along side the pooled investments. The CAS determines how the earnings from that fund are used on an annual basis. They may be spent for specific purposes or a portion may be added back to help the capital investment grow.

## Our Donors

#### Founders Circle

Donors who contribute \$2,000 to the Foundation by March 31, 2008 will be identified as members of the Founders Circle. They will be listed as such on our website and historical records forever. The confidence and financial commitment of these donors will provide a significant base from which to grow. Our goal is to welcome at least 100 donors to the Founders Circle before our next general meeting in April 2008.
